These disclosures must be updated throughout the year as new financial or other possible conflict of interest is obtained, as well as annually. The purpose of the disclosure is to enable the University to determine if outside interests and activities create a possible conflict, and disclosure is required by the Fort Valley State University's Conflict of Interest Policy.
