
This graduate studies program prepares students for many career options, including positions in biotechnology companies, veterinary science and medical fields, research sectors and food quality control and food processing industries.

- A passing score for the Regents' Test/ENGL 0054 or Graduate Studies Orientation/FVSU 0500.W6A.

To qualify for graduate assistantships, applicants must have:

- A cumulative undergraduate GPA of at least 2.75 or a graduate cumulative GPA of 3.40.
- A minimum composite score of 140 (verbal reasoning and quantitative reasoning) on the new GRE.
